

# Temporary Event Permit Type Revision

## SINGLE EVENT VENDOR PERMIT

The following temporary event permit types have been revised to align with the FDA model. Single event vendor permits have been consolidated into permit types that are based on food risk and not based on number of days. This has led to a change in permit names, permit fees, and permit criteria.

TFE Prepackaged Sampling 1-2 days: \$20 3-25 days: \$31 PE 1694 & 1695	TF Single Event Vendor, Low Risk \$30 PE 1918	Low Risk (prepackaged nonperishable food)	Prepackaged cookies, soda, beverages, chips, produce
TFE (Full Prep) 1-2 days: \$62 3-25 days: \$91 PE 1688 & 1689	TF Single Event Vendor, Moderate Risk \$61 PE 1919	Moderate Risk (preparation of nonperishable food)	Shaved Ice, Churros, popcorn, cotton candy, non-dairy beverages
TFE (Full Prep) 1-2 days: \$62 3-25 days: \$91 PE 1688 & 1689	TF Single Event Vendor, High Risk \$91 PE 1920	High Risk (any perishable food)	Burgers, tacos, bbq, pizza, hot dogs, fries

## MULTIPLE EVENT VENDOR PERMIT

TFE Prepackaged Sampling Annual Vendor \$42 PE 1696	TF Multiple Event Vendor, Low Risk \$42 PE 1915	Low Risk (prepackaged nonperishable food)	Prepackaged cookies, soda, beverages, chips, produce
TFE (Full Prep) Annual Vendor \$342 PE 1690	TF Multiple Event Vendor, Moderate Risk \$182 PE 1916	Moderate Risk (preparation of nonperishable food)	Shaved Ice, Churros, popcorn, cotton candy, non-dairy beverages
TFE (Full Prep) Annual Single Vendor \$342 PE 1690	TF Multiple Event Vendor, High Risk \$342 PE 1917	High Risk (any perishable food)	Burgers, tacos, bbq, pizza, hot dogs, fries
