- Tulare County Well Ordinance variances will require California Environmental Quality Act (CEQA) review prior to well permitting.
- 3. If the applicant name is a company or business, a written authorization letter is required for the person signing on behalf of the applicant.
- 4. No permit is required for exploratory borings less than 45' unless groundwater is encountered. If groundwater is encountered, work must stop and an application for a permit must be filed.
- 5. Application submittal requirements for Monitoring Wells: Only one application submittal is required if one or more monitoring wells are constructed on the same Assessor's Parcel Number (APN). Fee charges are based on the number APNs and Township, Range, and Sections (if monitoring well is constructed in a Right of Way) and not the number of monitoring wells being constructed.
- 6. Application submittal requirements for exploratory or geotechnical borings: Only one application submittal is required if one or more exploratory or geotechnical borings are all located on the same Assessor's Parcel Number (APN). Fee charges are based on the number APNs and Township, Range, and Sections (if borings are being drilled in a Right of Way) and not the number of exploratory or geotechnical borings.
- 7. Monitoring wells and exploratory or geotechnical borings Contractor will have to complete duplicate pages of the well construction information page if construction information varies. On Page 3, under "WELL Type", then "Other", list the GPS reading. Also, after "Number of Soil Boring(s) or Monitoring Well(s)" provide the name (Example: SB-1 or MW-1).
